



## **HEALER MEMBERSHIP APPLICATION**

### **Guidelines**

---

Please read these notes carefully before completing the form. All applicants for healer membership must be able to provide evidence to demonstrate competence as healers.

The Healer Assessment Panel aims to assess your:

- knowledge and understanding of the Code of Conduct
- dedication to providing healing to your clients
- commitment to personal and professional development
- demonstration of the healing act as taught by The Healing Trust

#### **GUIDANCE NOTE 1**

If you are working with a mentor as well as your tutor, they must be a current member of The Healing Trust, listed on the approved mentor list with the Office and not closely related to you.

#### **GUIDANCE NOTE 2**

You need 3 clients who will answer a standard testimonial questionnaire about your healing. Please ensure your clients receive this (the latest version of this can be found online). Please ask your testimonial clients to return the form to your tutor as soon as they can as this forms an important part of your healer Panel assessment.

Your clients must:

- have received healing from you within the 6 months prior to your panel date
- have received healing only from you during the period covered by the testimonial
- be able to testify in a questionnaire what they experienced from your healing sessions (spiritually, mentally, emotionally and/or physically)
- not include immediate members of your family (e.g. spouse or partner, children, siblings or parents)

#### **GUIDANCE NOTE 3**

Payment may be by cheque, credit or debit card. Overseas members may pay by credit card or bank transfer.

Please read the terms of your Declaration very carefully before signing (see page 2 of the Application Form).

### WHAT HAPPENS NEXT?

Once all your testimonials and Panel paperwork have been returned to your tutor, your tutor will send an anonymised copy to the Office.

**Online Panels:** You will then be notified by the Office of the date and time of your Panel if you have chosen to complete your Panel online.

**In Person Panels:** The office will liaise with your Regional Panel Co-ordinator (UK) to arrange a mutually convenient date. The Panel Co-ordinator will need 3 applicants to be available for Panel before they can confirm a date. Some regions can only hold Panels twice a year due to geographical considerations, whilst other Regions can hold Panels every 2-3 months. Please be patient while waiting to hear your Panel date. Every effort is made to ensure that you can attend a Panel as soon as possible, at a convenient time for you. We remind you that all Panel personnel are volunteers of The Healing Trust.

If you wish, you may apply for a Panel in another region. Please advise the Office of this when you send in your application form.

Overseas students may request an online Panel – please advise the Office if this is the case.

Please allow a minimum of 3 months from the start of your application until your Panel date.

Your Panel assessment will last for approximately 1½ hours, with 3 experienced volunteer healer members present. They will have read your Student Log, testimonials and case studies. They will ask you 25 questions on the Code of Conduct, some general questions about your healing journey, and you will be asked to give a demonstration of the healing act of approximately 20 minutes, plus client care, totalling approximately 30 minutes.

On passing your Panel, the Panel Chairperson will send the Panel report to the Office. The Office will send you your healer membership pack with a certificate and healer membership card, ready to start a new stage of your journey as a healer member of The Healing Trust.

You will be eligible to use the initials 'MHT' and given access to the healer resources on The Healing Trust website where you can upload your photo and profile as a healer member on the public facing 'Find A Healer' register. You will also be eligible to apply to UK Healers to be added to their public register of healers.
